



# **RIIMPO337D Conduct articulated haul truck operations**

#### Introduction

The program provides learners with skills and knowledge relating to plant equipment, how to operate an articulated haul truck and general machinery knowledge. This includes general mechanical skills combined with a specific focus on how to operate this machine from scratch or advance your skills in a fully operational environment.

Learners will be empowered by this course and be equipped with the right knowledge and the confidence to commence employment operating a haul truck immediately. Learners will gain a nationally recognised qualification in the Conduct articulated haul truck operations (RIIMPO337D).

## **National recognition**

This unit of competency has been drawn from the nationally endorsed qualification Certificate III in Civil Construction Plant Operations (RII30813 Resources and Infrastructure Industry Training Package). On successfully completing the training and assessment, a statement of attainment will be issued for RIIMPO337D Conduct articulated haul truck operations. This unit of competence is nationally recognised and provides individuals with a valuable qualification that can be applied throughout Australia in the civil construction, mining and rail industries.

# **Program outline**

The course will be delivered in a fully operational quarry using one-on-one training and assessment. We hold the course here as it is as close as possible to what working in the industry is like, this way you are very well prepared to commence work. Training sessions are trainer led. The modules are sequenced in a way that allows a logical progression. Participants will be provided with professionally presented reference material to assist them to develop their knowledge of the subject. Classes will be delivered at one of our training sites 481 Castlereagh Rd, Agnes Banks NSW or 302 Pitnacree Road, Raworth NSW 2321.

#### **Expected duration**

The program is designed to be delivered over 3 days. MSK Resources are able to support participants that need additional time.





## **Assessment requirements**

The student will be assessed by demonstrating procedures applicable to this unit. They will also be required to answer a number of oral and written questions regarding their actions and theoretical application of knowledge. The assessment may be part of the student's day-to-day work routine or simulated activity set by the assessor.

This assessment must be conducted by an RTO assessor and must be completed in the workplace or in another environment that accurately simulates the workplace. The assessor is to actively set tasks for the student and must observe these tasks being performed. Assessors will apply an assessment procedure to ensure you are ready for the assessment and have the right resources and equipment to achieve the right standard.

#### **Entry requirements**

All Students who wish to enter the course must be 18 years of age and hold or have held a current Australian drivers license. It is desirable that students entering the program have a good knowledge of the English language. It is acknowledged that many students will have experience in a relevant role that will have provided a suitable preparation for the program. It is usually the case that personnel entering this program are identified by their employer based on their need for professional development and growth.

#### **Recognition of Prior Learning**

Applicants can apply for recognition of their existing skills and knowledge that is relevant to the unit of competence being delivered in this program. These skills and knowledge may have been obtained through workplace training or experience and may lead to a reduction in the need for training. Students are encouraged to notify MSK Resources of their interest or intention to apply for RPL prior to their enrolment.
